## COMPANY'S SECURITY POLICY

The overall security policy of Acechem Tanker is to prevent injury or loss of life to our crew, visitors, other employees, or any other person and avoid damage or loss of property to our ships and cargoes or any other property through the activities of terrorist or other criminal organization.

The Company has established security measures onboard to detect security threats and to take preventive measures against security incidents that may affect safety security of our ship, personnel, and the port facilities, in full compliance with SOLAS Chapter XI-2 and ISPS Code.

The Master and all crew members should give effect to those requirements stipulated in SSP and should be familiar with their duties. They should also undergo necessary training given by the master or the SSO onboard.

The Company hereby declares that;

The Master has the overriding authority and responsibility to make decisions with respect to the safety & security of the ship. And if , in his professional judgement, a conflict between safety and security matters arises , he will give effect to those requirements necessary to maintain the safety of the ship.

Establish safeguards to reduce risk to crew and port personnel onboard company ships.

Maintain close liaison with third parties including government agencies, coastguard authorities, charterers etc.

Prepare contingency measures for emergencies relating to possible security incidents.

Regular documented reviews, updates and internal audits of security procedures and plans, are carried out to allow for constant update and improvement to the plan.

The Company should give necessary support to the CSO, Master and SSO to carry out their duties with respect to security
